3. Task Group Reports

a. Resourcing Ministerial Education.


Consultations are in the early stages but implications huge in terms of resources, eg increasing numbers by 50%; deployability issues. MS waiting for visit from central church before proceeding. Could improve what's going on with something creative. +Steven Croft issued update yesterday: continuing consultation with visits. Questionnaire has been issued to all bishops with short response deadline; updates should be issued in autumn 2015. There have been criticisms about the lack of theology which has been omitted on purpose. It is not a cost-cutting exercise – it is a huge investment – the biggest ever in theological education. Funding changes will ensure that expenditure decisions are made near where the expenditure occurs. Dioceses can choose to do all sorts of things from pooled resources. Leads to increased opportunities and increased risks. One of the keys to the viability of All Saints is its combination of Reader and Ordination training. Some have argued that real costs of residential training are obscured by current arrangements.

b. Developing Discipleship

Diocese of Chester PW training course is unique. The University of Chester has encouraged its oral assessment, although this is labour-intensive. Requires the reintroduction of a lay training officer. A business plan is required which details student and facilitator targets. Something between FfM and training for lay ministries is often requested. The deadline for rewriting is autumn 2015. Should encourage those with leadership skills who aren't lay ministers. FfM costs can be covered: need to make people theologically literate and equipped with

leadership skills.
